#### 1. CALL TO ORDER AND ROLL CALL

#### 3. EXECUTIVE DIRECTOR'S REPORT

Ms. Carrillo reported that under the Sales and Use Tax Exclusion (STE) Program, if the applications under consideration today are approved, CAEATFA will have awarded approximately 74% of the total STE for the calendar year, leaving \$25.9 million to award. CAEATFA currently has five applications under review, and if they are all approved, \$22.4 million in STE would be remaining for the rest of the year.

Ms. Carrillo also reported that a new Property Assessed Clean Energy ("PACE") Program was enrolled in the PACE Loss Reserve Program: the CSCDA HERO Program. This brings the total number of enrolled PACE programs to 15 under the PACE Loss Reserve Program.

Ms. Carrillo reported that CAEATFA is continuing to monitor Senate Bill 242, authored by Senator Skinner, which strengthens PACE underwriting criteria as staff concurrently works with stakeholders on revised regulations for the PACE Loss Reserve Program.

Ms. Carrillo stated that Staff would present an informational item on the California Hub for Energy Efficiency Financing (CHEEF) provided by Miriam Joffe-Block, Program Manager. She noted that the presentation today would inform the Board of the progress of the CHEEF Pilot Programs, including the Residential Energy Efficiency Loans Program and anticipated progress in rolling out other phases of the Program.

Ms. Joffe-Block provided a presentation on the CHEEF Pilot Programs.

Ms. Carrillo indicated that she was proud of the hard work of the CHEEF staff and pleased that the Program could be highlighted for the Board.

Mr. Juarez wanted to ensure that as the CHEEF moves into the commercial field, the California Business Gateway is included as a resource. Mr. Mack stated that the Public Utilities Commission has increased optimism over the implementation of the CHEEF Pilot Programs and has provided its support in the increased leeway provided to the Program.

Ms. Carrillo also reported that under her delegated authority, she executed the contract resulting from the Request for Proposal (RFP) (CAEATFA 10-16) for the Trustee Services for the PACE Loss Reserve Fund to Zions Bank. CAEATFA received three proposals and selected Zions Bank as the most cost effective, for a contract not to exceed \$16,550.00 for a two year term, including an optional one-year extension.

Ms. Carrillo then concluded her report.

#### 4. BUSINESS ITEMS

# A. DISCUSSION AND CONSIDERATION OF APPLICATIONS FOR SALES AND USE TAX EXCLUSION

### 1. Pacific Ethanol Stockton

Presented by Ashley Bonnett, Program Manager

Ms. Bonnett reported that Pacific Ethanol Stockton, LLC is an Alternative Source Applicant requesting a Sales and Use Tax Exclusion award to construct an anaerobic digestion system to produce biogas for use at the Stockton Combined Heat and Power facility, which powers the ethanol production process at Pacific Ethanol Stockton. The Applicant represents the project will produce biogas to replace approximately 40 million btu per hour of natural gas currently used by the Stockton Combined Heat and Power facility, enough biogas to fully meet the gas demand currently required at the facility to produce ethanol, reducing the carbon intensity score of the ethanol production process.

Staff recommends approval of a resolution for Pacific Ethanol Stockton's purchase of no more than \$5,932,500 in Qualified Property anticipated to result in an approximate Sales and Use Tax Exclusion value of \$499,517.

Ms. Ortega moved for approval and there was a second by Ms. Baker.

## 2. Sanitation Districts of Los Angeles County Presented by Ashley Bonnett, Program Manager

Ms. Bonnett reported that Sanitation Districts of Los Angeles County is an Alternative Source Applicant producing renewable gas. They are a public agency providing wastewater and solid waste management for 5.6 million people in Los Angeles County

and have applied for a Sales and Use Tax Exclusion award to expand operations at their current waste processing facility. This will include the addition of DODA bio-separators which will extract a slurry from the waste stream that can be added to existing anaerobic digesters for the production of renewable gas. This project will span two separate locations with the slurry extracted at the Sanitation Districts' materials recovery facility in Whittier, California and transported to their Joint Water Pollution Control Plant in Carson, California for conversion into renewable natural gas. This renewable gas will be distributed at the Sanitation Districts' own fueling station.

Staff recommends approval of a resolution for the Sanitation Districts of Los Angeles County's purchase of no more than \$11,928,310 of Qualified Property, anticipated to result in an approximate Sales and Use Tax Exclusion value of \$1,004,364.

Ms. Ortega moved for approval and there was a second by Ms. Baker.

#### 3. Recology San Francisco

Presented by Ashley Bonnett, Program Manager

Staff introduced Meghan Butler, Corporate Development Manager, Recology San Francisco

Ms. Bonnett reported that Recology San Francisco is a Recycling Applicant processing waste for the Bay Area. The company has applied for a Sales and Use Tax Exclusion award to expand their materials recovery facility operations. The expansion will allow Recology San Francisco to extract additional waste from the waste stream in the form of a paste that will eventually be converted to energy by the East Bay Municipal Utility District. The Applicant predicts that an additional 7,000 tons of waste will be diverted from landfills annually once the Project is complete.

Staff recommends approval of a resolution for Recology San Francisco's purchase of no more than \$3,633,145 of Qualified Property, anticipated to result in an approximate Sales and Use Tax Exclusion value of \$305,911.

Ms. Ortega moved for approval and there was a second by Ms. Baker.

Mr. Juarez stated there was a motion and a second and asked if there were any other questions or comments from the Board or public. There were none and the item was unanimously approved.

# B. REQUEST TO APPROVE REGULATIONS FOR THE SALES AND USE TAX EXCLUSION PROGRAM

Presented by Ashley Bonnett, Program Manager

On July 18, 2016, the CAEATFA Board approved emergency regulations modifying the Sales and Use Tax Exclusion ("STE") Program to incorporate Recycled Feedstock projects eligible under the newly enacted Assembly Bill 199 and to enhance and streamline Program administrative processes to address the Program's oversubscription and incorporate lessons learned while implementing the Program.

After the emergency regulations became effective, CAEATFA staff continued to evaluate program implementation and identified two modifications to incorporate in the proposed regulation text that is before the Board today.

First, the initial emergency regulations limited Recycled Feedstock projects to those not eligible for an STE as an Alternative Source, Advanced Transportation, or Advanced Manufacturing Project because at the time the regulations went into effect, the Board had implemented an STE set-aside for Recycled Feedstock projects in light of the Program's oversubscription. To best effectuate the purpose of the set-aside, the regulations limited Recycled Feedstock project eligibility to those that did not previously have the opportunity to be considered for an STE award.

Because there is no longer a set-aside for Recycled Feedstock projects, limiting the pathways by which a project can apply is not necessary. The proposed modifications to the regulations remove this limitation from the definition of Recycled Resource Extraction Project.

Second, to help address the STE Program's oversubscription, the emergency regulations instituted a project cap of \$20 million in STE, with the possibility of receiving additional STE if any of the \$100 million annual statutory cap remained at the end of the year. CAEATFA staff subsequently identified a loophole created by defining the cap as per project: Applicants could split projects into multiple applications or projects and take up all or a significant portion of a year's STE allocation. Therefore, the proposed modified regulations limit applications to \$20 million in STE per Applicant per calendar year. Additionally, if an Applicant has a parent company with greater than 50% ownership interest, the \$20 million cap applies to that parent company and its subsidiaries or affiliates. Because the cap now applies to Applicants, the proposed regulations also clarify that an Applicant may submit a revised application (for a previously approved project), or a new application (for a separate project) if any of the \$100 million in STE remains at the end of the calendar year.

A Notice of Proposed Rulemaking and the proposed regulation text before the Board today was published in the California Notice Register on May 12, 2017, beginning a 45-day public comment period, during which CAEATFA staff did not receive any public comments. CAEATFA staff also held a public workshop discussing the proposed regulations on June 27, 2017, and did not receive any public comments or questions at the workshop. If the regulations are approved by the Board, CAEATFA staff anticipate filing the Certificate of Compliance with the Office of Administrative Law tomorrow, July 19<sup>th</sup>.

Staff recommends approval of the proposed regulations for the Sales and Use Tax Exclusion Program.

Mr. Juarez indicated that he was supportive of the STE regulation changes, particularly in regards to the change that will provide a per-applicant cap compared to the per-project cap.

Ms. Ortega moved for approval and there was a second by Ms. Baker.

Mr. Juarez stated there was a motion and a second and asked if there were any other questions or comments from the Board or public. There were none and the item was unanimously approved.
