To All Interested Parties:

This report presents the results of bond and tax measures for the Primary Election held June 7, 1994 and the General Election held November 8, 1994. This is the sixth in a series of reports on general elections in California prepared by the California Debt Advisory Commission.

The results indicate that there were 61 measures tracked in the June election, 23 passed (38 percent) and 38 failed (62 percent). In the November election, 93 issues were monitored, and the results were similar, with 37 measures passing (40 percent) and 56 (60 percent) failing. Voters were particularly disinclined to support State and local general obligation (G.O.) bond measures which appeared on the ballot. All of the State's general obligation bond proposals were defeated (four in June, one in November) and only five of 15 local G.O. bond proposals in June and six of 24 in November were successful. In both elections, significantly more local G.O. issues would have passed, if majority vote provisions were in place (i.e., nine of the ten failing issues received in excess of 50 percent voter approval in June, and 16 of the 18 defeated measures in November tallied at least 50 percent approval). Sales tax and special tax measures, designed to fund public services such as public transit, libraries, police, emergency medical and fire, were also defeated at a fairly high rate, with only 13 of 36 passing in the June Primary Election and just 21 of 62 measures realizing success in November.

This report includes a narrative on the results of the two statewide elections, as well as data on the individual tax and bond ballot measures themselves. The Commission would like to recognize the contributions of the Secretary of State's Office and the elections departments of the 58 county clerks' offices in preparing this report.

# STATE AND LOCAL TAX AND BOND BALLOT MEASURES

Summary of Primary and General Election Results  
June 7, 1994 and November 8, 1994

## I. INTRODUCTION

This report presents the results of the 1994 Primary and General elections held in California. Included is data on all statewide and local bond and tax measures from information received from the California Secretary of State's Office and the 58 county clerks' election departments. The Commission has published general election results in a series of reports since November 1986.

### Primary Election Results

Over 60 percent of the bond and tax measures tracked by the California Debt Advisory Commission were defeated at the June 7, 1994 Primary Election. Out of a total 61 measures reported, 23 passed (38 percent) and 38 failed (62 percent). These numbers include the four State of California general obligation bond measures which were defeated. Local governments going to the polls with bond or tax measures were successful on 23 of the 57 measures on the ballot--a 40 percent passage rate. The number of measures followed in this election was up slightly from the June 1992 Primary Election when 53 measures were tracked.

### General Election Results

The Commission received information on 93 bond and tax measures presented in the November 8, 1994 General Election. In the election, 37 measures (40 percent) passed and 56 (60 percent) were defeated--a passage rate slightly above the June election. Just as in the June election, the State of California's general obligation bond measure (Proposition 181) was soundly defeated, as was the State's gasoline sales tax proposal (Proposition 185). Local agencies passed 37 measures and defeated 54 for a 41-59 percent split. The total number of measures reported is down somewhat from the 116 measures included in the 1992 General Election. This continues the downward trend towards fewer finance measures presented to the voters in the last several years. The number of issues and rate of approval has dropped in the past three general elections as noted below:

- November 1988, 173 measures presented, 53 percent approved;
- November 1990, 147 measures, presented, 37 percent approved; and
- November 1992, 116 measures presented, 30 percent approved.



## **JUNE 7, 1994 PRIMARY ELECTION**

### **II. SUMMARY OF STATE AND LOCAL BOND MEASURES BY PURPOSE**

#### **A. Education**

There were 21 education issues presented to the voters in the June election. Fourteen K-12 school facilities, one college and university facilities bond measure, one educational program and five special tax measures for library services. Of that number, 10 measures were successful. Five of the K-12 measures and five library measures passed. These numbers mirror the June 1992 Primary election when five K-12 bond measures were also approved.

#### **B. Capital Improvements and Public Works**

Thirteen measures, tracked in this election, fall into the general category of capital improvements and public works. This is a 31 percent passage rate, down slightly from the 35 percent approved in the June 1992 election when six of 17 measures were approved.

Included in the category were proposals for parks and recreation facilities, power generation and transmission facilities, public transit programs, bridges and highways, seismic safety projects, and multiple capital improvements and public works. Only four of the 13 measures passed. Two parks and recreation tax measures were approved; Dutch Flat Community Services District Area 28 in Placer County approved a tax for a swimming pool and the Santa Clara County Open Space District approved an advisory vote for parks and open space development. Monterey and Ventura counties, who proposed measures to use their Motor Vehicle License fees for public transit and pathways in their respective counties, received approval for their measures.

#### **C. Life Support**

Of the 19 issues proposed to increase or enhance police, fire, or emergency medical services, just six were approved, a 46 percent passage rate. Successful measures included a police services tax in the Fresno County Fig Garden Police Protection District which passed the measure with a whopping 83 percent; a continuation of a tax and an additional tax for fire suppression services in the Marin County Services Areas No. 19 and 31 respectively; for fire protection in the Monterey County Greenfield Fire Protection District and Mt. Shasta in Siskiyou County, and approval of a lease arrangement with a non-profit organization for an emergency services center for the San Francisco City and County.

#### **D. Miscellaneous Purposes**

The remaining measures included three hospital and health care proposals. Only one, a special tax passed by the voters in Modoc County Surprise Valley Hospital District, passed. Five general government proposals were voted upon; two passed while three failed. Measures for general government were approved in Marina, Monterey County, and East Palo Alto in San Mateo County.

### **III. BONDS**

#### **A. State General Obligation Bonds**

The State of California's general obligation bond measures included Proposition 1A, (\$900 million for higher education facilities); Proposition 1B, (\$2 billion for earthquake repair and seismic safety); Proposition 1C, (\$1 billion for K-12 school facilities); and Proposition 180 (\$2 billion for parkland conservation). They all failed to garner the fifty percent approval needed for passage. Final figures show that only Proposition 1C for K-12 school facilities came close with a 49.6 percent approval. The total proposed amount for the State bonds was \$5.9 billion.

#### **B. Local General Obligation Bonds**

Local agencies passed five of 15 general obligation bond measures on the June ballot. Of the ten measures that failed, nine received at least 50 percent approval, but fell short of the two-thirds necessary for passage. In Vallecito Union School District in Calaveras County and Mountain View-Los Altos High School District in Santa Clara County, local G.O. bond measures received 66 percent of the popular vote, but were nonetheless defeated.

The five general obligation bond measures that were approved totaled \$167.5 million, all earmarked for K-12 school facilities. Defeated measures included funds for eight K-12 school facilities; and single proposals for health care facilities in Inyo County and for the purchase of power transmission lines in the Embarcadero Municipal Improvement District in Santa Barbara County.

A summary of State and Local General Obligation Bonds is in Table A-1 beginning on page A-1.

### **IV. TAX MEASURES**

#### **A. Use and Transactions (Sales) Tax**

There were three sales tax measures reported; one each in Merced, Sutter, and Yuba Counties. All three failed. They each needed majority approval, but only received between 46 and 48 percent.

#### **B. Special Tax Measures**

Special tax measures represented the greatest number of tax measures submitted to the voters. These special tax measures fared slightly better than general obligation bond measures, with 13 passing (40 percent) to 20 failing (60 percent). Six of the special tax measures were advisory only, with only two of those being approved.

Generally, special tax measures must receive two-thirds majority for passage. All five measures on the ballot to provide library services passed, and one proposal for educational services failed. Five of 17 special tax measures to provide life support services passed. The one Mello-Roos Community Facilities tax measure on the ballot, a proposal for \$3.1 million for Tiburon CFD No. 1994-1, failed.

### **C. General Tax Measures**

Voters in the cities of Marina in Monterey County and East Palo Alto in San Mateo County approved general tax measures for general government purposes. They needed a simple majority for passage.

### **D. Other Tax Measures**

In the *Other Tax Measures* category, the City and County of San Francisco approved a proposal to allow the City and County to enter into a \$60 million lease program with a non-profit corporation to construct a dispatch center for police, fire and emergency services.

## NOVEMBER 8, 1994 GENERAL ELECTION

### V. SUMMARY OF STATE AND LOCAL BOND MEASURES BY PURPOSE

#### A. Education

The greatest number of measures presented to the voters in the November General Election were for education purposes. There were 38 proposals--16 passed and 22 failed. The measures include general obligation bonds for the construction of school facilities, special tax measures and re-authorizations of existing special taxes for school programs, as well as proposals to provide for library services. The approval number is deceiving because four of the passing measures were approved in Santa Cruz County where the County proposed a sales tax measure to collect funds for library services county-wide. Local agencies would contract with the County to use a portion of the sales tax revenues for their library services. All of the local agencies approved measures to apportion the sales tax, but the county sales tax measure was defeated, so the plan will not be implemented. Two library services measures, in Santa Clara County were also approved, but were advisory only.

The Willows Joint Unified School District boundaries span three counties, so there were three G.O. bond measures for the K-12 school facility on the ballot one each in Napa, Yolo and Solano counties. All measures were defeated.

#### B. Capital Improvements and Public Works

Only eight of the 26 ballot measures for capital improvements and public works projects passed. They include funds for the repair and renovation of the Old Main Library and Asian Art Center and the approval for the issuance of revenue bonds for wastewater treatment facilities in San Francisco. Approvals were also received for special taxes for engineering for wastewater treatment facilities in the Spalding Community Services District in Lassen County; for street construction in Beyers Lane Community Services District in Nevada County; and for park facilities in the Spreckles Memorial Park District in Monterey County. Also approved was the motor vehicle license (MVL) fees for public transit in Glenn County; an advisory vote on parks in the Midcoast Community Services District in Monterey County, and conditions on the issuance of general obligation bonds for underground utilities in the Embarcadero Municipal Improvement District. (This issue is moot because its companion measure to issues general obligation bonds for underground utilities was defeated.)

#### C. Life Support

Life support measures include fire and police protection services, and emergency medical services. There were 21 measures proposed; of that number, 10 passed and 11 were defeated. Most of these measures needed a two-thirds vote for passage.

## **D. Miscellaneous Purposes**

One hospital measure, the Bear Valley Community Hospital District in San Bernardino County, passed, and one for the Corcoran Hospital District in Kings County, failed. There was approval of advisory measures for animal control services in Butte County and to end a utility users tax in Lincoln in Placer County.

This election featured several novel approaches to funding public services and facilities. In one case, the City of Long Beach proposed a G.O. bond to fund repairs and retrofit public buildings to comply with the Americans with Disability Act provisions. It met defeat. In another, Sacramento County proposed a sales tax that, if passed by a majority of voters would be used for general government services; if passed by two-thirds majority, would be used to provide funds for police and fire services. The voters defeated the measure 27 to 73 percent. There were also proposals to build television translators, maintain a retaining wall, and a memorial building.

## **VII. BONDS**

### **A. State General Obligation Bond**

The one general obligation (G.O.) Bond measure presented to the voters, Proposition 181, the third part of the *Passenger and Clear Air Bond Acts* proposed for \$1 billion, was defeated by a 35 to 65 percent vote. This is the last installment of three separate rail bond measures authorized by the Legislature in 1989. The first of the three rail bond measures, Proposition 111 for \$1 billion, was passed in 1990; and the second, Proposition 156 for \$1 billion, was soundly defeated in the 1992 November General Election. This marked the first election in a number of years where there was only one statewide general obligation bond measure on the ballot, and the author of the legislation, noting the voters' anti-bond mood, tried unsuccessfully to remove it from the ballot in the waning days of the 1994 legislative session.

### **B. Local General Obligation Bonds**

Local G.O. measures fared poorly throughout the state. Just six of 24 proposals were approved; one a \$41.7 million issue for the City and County of San Francisco's Main Library and Asian Art Museum, and five K-12 school facility issues in the Oakland Unified School District, the El Rancho Unified School District, the Victor Valley Union High School District, the Scotts Valley Union Elementary School District and the Healdsburg Union High School District. The total amount of G.O. bonds approved was \$290.7 million.

As in the past several years, the two-thirds vote proved to be a stumbling block as 16 of the 18 measures received majority approval, but not the 66 2/3rds necessary for passage. In fact, voters in Vallecito Union School District in Calaveras County and City of San Anselmo in Marin County defeated bond measures which received 66.4 percent and 66.5 percent vote respectively. This is

the second vote for the Vallecito Union School District which was barely defeated (see the June Election above). The defeated G.O. bond measures totaled \$743 million.

Summary Table B-1, a listing of State and Local General Obligation Bonds, begins on page B-1.

## **VIII. TAX MEASURES**

### **A. Use and Transaction (Sales) Taxes**

None of the sales tax measures presented on the November ballot passed. The State of California proposed through the initiative process, the *Public Transportation Trust Funds/Gasoline Sales Tax*, Proposition 185, a 4 percent tax on gasoline. It was defeated by a vote of 20 to 80 percent.

Local agencies fared no better. The sales tax measures for Sacramento and Santa Cruz counties and Sutter and Yuba County Transportation Authorities were defeated. As noted in the discussion on purposes, Sacramento and Santa Cruz counties attempted to fund public services by sales taxes in innovative ways, but met with defeat.

### **B. Special Taxes**

The most prevalent type of tax proposed in this election was once again the special tax. Forty-seven measures were advanced: 21 passed and 26 were defeated. The passage rate is somewhat altered when it is noted that four special tax measures were advisory only and eight were extensions of taxes that had been in effect previously. That leaves only nine new special tax measures approved. The majority of tax measures which were approved continue or add to life support services in communities. Although local agencies are attempting to preserve and extend library services in their communities, the only proposal that passed was in the Lassen Library District. Of those measures that failed, ten were for life support services with seven each for educational or capital improvements and public works projects. Table B-3 summarizes the special tax measures.

### **C. General Tax Measures**

One general tax measure was approved--an advisory measure to repeal the 5 percent utility tax in the City of Lincoln in Placer County. Since it was only advisory, it will be up to the Lincoln City Council to implement the voters voice. The other four measures were proposals to add or increase utility taxes and were defeated by significant margins of 11 percent to 32 percent. The summary of the five issues appears on Table B-4.

### **D. Other Local Measures**

This category contains tax or bond related measures. As such, the measures that passed are a mixed bag. In the Albany Unified School District and the Paradise Unified School District voters were asked to approve additional uses for bonds that were already authorized. Glenn County

residents approved the use of MVL fuel tax revenues for public transit purposes in their county. And voters in San Francisco City and County approved the issuance of \$146 million in revenue bonds for wastewater collection and treatment facilities. The Embarcadero Municipal Improvement District, noted above, approved various conditions to issuance of G.O. bonds for underground utilities, but the G.O. issue was defeated; and last, but not least, four cities in Santa Cruz County approved contracts for the use of sales tax revenues for library services, but the primary proposal for a county-wide sales tax was defeated.

In an initiative measure in Oakland, voters were asked to dissolve the Landscaping and Lighting District which would eliminate the \$15 million funding source for the maintenance and improvement of parks and street lighting in the city. The measure was defeated 29 to 71 percent. The other local measure was a proposal by the Town of Tiburon to be authorized to issue \$1.9 million in limited tax obligation bonds and levy a special tax to pay for a police and administrative facility. That measure was barely defeated 66.1 percent to 33.9 percent. Noted in the June Election summary is also a measure from Tiburon which was also defeated by a 54-48 percent vote. Table B-5 presents the summary information on these measures.

#### **VIII. COUNTIES REPORTING NO LOCAL BOND OR TAX MEASURES**

Twenty-three of the State's 58 counties reported no local bond or tax measures. They are: Alpine, Amador, Colusa, Del Norte, El Dorado, Glenn, Imperial, Inyo, Madera, Mariposa, Merced, Modoc, Mono, Plumas, San Benito, San Joaquin, Sierra, Siskiyou, Tehama, Trinity, Tulare, Tuolumne, and Ventura counties.
