INTRODUCTION

Constitutional and statutory provisions require voters to authorize general obligation (GO) bonds issued by state and local governments. For bonds issued by the state, the authorization must be made through a statewide election. Local bonds must be approved by voters within the jurisdiction authorizing the bond. The state and local governments must also seek voter approval for levies of certain revenue exactions and taxes. For both state and local measures, the voter approval threshold depends on the type and purpose of the bond or tax (see Figure 1).

After each statewide election, the California Debt and Investment Advisory Commission (CDIAC) publishes a statistical summary and review of bond and tax measures appearing on state and local ballots. This report, the 33rd in the series, covers local and Primary elections held in 2018. The report also contains an appendices, which summarize the measures by county, region, type of fiscal measure, and purpose.

SUMMARY OF THE CALIFORNIA 2018 LOCAL AND PRIMARY ELECTIONS RESULTS

- *Total measures* – Voters were presented with 121 local fiscal measures and two State of California measures. Of the 121 local measures, 103 measures appeared on the June 5, 2018 statewide primary ballots and 18 appeared on local, non-statewide ballots from January through May.
- *Approved measures* – Voters approved 93 (75.6 percent) measures, of which 35 were general obligation (GO) bond measures, 33 were special tax measures, 24 were general tax measures, and one bridge toll measure.
- *Passage rates* – In the Primary Election, general tax measures received the greatest support from voters with an 87.5 percent approval rate. Whereas in the local elections, more voters supported special tax measures with a 58.3 percent approval rate. (Figure 2)

General Obligation Bond Measures

- *GO Bond measures only appeared on the Primary Election ballots* - Voters were not presented with GO bond measures in any of the local elections held from January 2018 through May 2018.
- *Strong support for GO bond measures* – Voters approved 83.3 percent of these measures in the Primary Election. (Figure 3)
- *Volume of approved measures* – Voters approved approximately \$6.8 billion in GO bond measures.
- *K-12 educational focus* – 85.7 percent of the GO bond measures were for K-12 education. (Figure 4)
- *Support for K-12 educational GO bonds* – Voters approved 86.1 percent (approximately \$2.3 billion) of K-12 education GO bond measures.
- *Passage requirement for GO bonds* – The two college facilities and each of the 36 K-12 educational GO bonds required 55 percent voter approval for passage, including the Jefferson Union High School GO bond for teacher and staff affordable housing. The remaining GO bond measures required two-thirds voter approval.
- *State of California GO bond measure* – Voters approved the \$4 billion State GO bond measure, Proposition 68 for parks, the environment, and water (56.7 percent). This bond measure required a majority vote.

Tax Measures and Bridge Toll

- *Support for tax measures* – Voters approved 71.6 percent of general and special tax measures. (Figure 5)
- *Support for general tax measures* – Voter support for general tax measures was only 50 percent for the 2018 local elections. However, support for general tax measures in the 2018 Primary Election was high (87.0 percent passage rate).
- *Majority vs. two-thirds voter approval requirement* – General tax measures only need a majority of the vote to pass. If these measures had a two-thirds voting requirement, only 33.3 percent (local elections) and 69.5 percent (Primary Election) of the general tax measures would have passed. In contrast, special tax measures, which typically require two-thirds voter approval to pass, had less support: 58.3 percent (local elections) and 69.2 percent (Primary Election). If these measures required a majority vote, 83.3 percent (local elections) and 89.7 percent (Primary Election) of the measures would have passed.¹
- *Purpose of taxes* – Fifty-one of the tax measures (12 local election and 39 Primary Election) were special taxes for education, public health and safety, and miscellaneous purposes. The remaining 29 tax measures (six local election tax measures and 23 Primary Election measures) were for various general government purposes. (Figure 6)
- *State of California property tax measure* – Voter support (84.2 percent) of Proposition 72, which excludes rainwater capture systems from property tax assessments beginning January 2019, was strong.
- *Bridge Toll* – The Metropolitan Transportation Commission in the Bay Area presented voters with a bridge toll measure, which required majority approval. Voters supported the measure (55.1 percent).

¹ There was one special tax measure, Proposition G, Living Wage for Educators Act of 2018, from the City and County of San Francisco that required simple majority voter approval instead of two-thirds due to its Home Rule Powers. This measure passed with 60.8 percent voter approval.

Results by Region

The election results are divided into five regions: Bay Area, Central Valley, Los Angeles, San Diego/Inland Empire, and Other. (Figure 7)

- *Proposed Measures* – For the local and Primary elections, the Bay Area and "other" region voters were presented with the most measures (36 measures each).

- *Passage Rates* – The region with the highest passage rate in the local elections is the Bay Area (100 percent). In the Primary Election, the San Diego/Inland Empire and "multiple" regions each received a passage rate of 100 percent, followed by the Los Angeles region (86.7 percent) and the Bay Area region (84.8 percent). In the local elections, the Central Valley region did not receive any voter approval (0.0 percent). In addition, this region also received the least voter support in the Primary Election (64.7 percent).

COMPARISON OF THE 2016 AND 2018 PRIMARY ELECTIONS

- *Comparative passage rates* – The passage rate of bond and tax measures during the 2018 Primary election (79.0 percent) was slightly higher than the 2016 Primary Election passage rate (77.5 percent). (Figure 9)
- *Comparative number of approved measures* – The number of approved measures (83) in 2018 was also higher than the approved measures (69) in 2016. (Figure 10)
- *Special tax measure passage rates* – The passage rate for special tax measures was higher in 2018 (68.4 percent) than 2016 (53.9 percent). (Figure 10)
- *Regional passage rates* – In the 2016 Primary Election, the Bay Area region had the highest passage rate (91.4 percent), but in the 2018 Primary Election, the San Diego/Inland Empire (100.0 percent) and Los Angeles (86.7 percent) regions had the highest passage rates. (Figure 11)
- *General government measure passage rates* – General government measures had a higher passage rate in 2018 (87.0 percent) than 2016 (72.7 percent). (Figure 12)
- *Passage rates by purpose* – In 2016, the passage rate for education was the highest (88.0 percent). In 2018, capital improvements and general government measures had the highest passage rate (100.0 percent and 87.0 percent, respectively). (Figure 12)
- *Comparative number of proposed local measures* – In both Primary Elections, the highest percentage of proposed local measures was for educational use. (Figure 12)

Figure 12 summarizes the types of projects appearing on the Primary Elections ballots. Projects that comprise the miscellaneous category include the following: storm drainage, library facilities and services, trail maintenance, bankruptcy obligations, parks and recreation, housing, exclusion of rainwater capture systems from property tax assessments, gang prevention services, levee improvements, childcare/early education, bike paths, and homeless programs.

SUMMARY

The 2018 local elections that were held before the 2018 Primary Elections were comprised solely of tax measures, which included marijuana, special, and general tax measures. The only GO bond measures presented to the voters appeared on the 2018 Primary Election ballots. In addition, the passage rate for the measures in the local elections was significantly lower (55.6 percent) than the passage rate in the Primary Election (79.0 percent).

The passage rate of bond and tax measures for the 2016 Primary Election and the 2018 Primary Election were 77.5 percent and 78.6 percent, respectively. However, there were more measures in the 2018 Primary Election than the 2016 Primary Election, which is attributable to the 14 miscellaneous measures on the 2018 Primary Election ballots. In both the 2016 and 2018 Primary Elections, voter support for public health and safety measures was lower than the other measures. Unlike the 2016 Primary Election, voters were presented with and approved two State measures in the 2018 Primary Election: one GO bond measure for parks, the environment and water, and one property tax-related measure to exclude rainwater capture systems from property tax assessments.
