OPEN SESSION

The meeting of the California Debt Limit Allocation Committee (Committee) was called to order at 1:33 p.m. by Bettina Redway, Deputy Treasurer.

Call to Order and Roll Call (Agenda Item 1)

Bill Lockyer, State Treasurer, represented by Bettina Redway, Deputy Treasurer; Arnold Schwarzenegger, Governor, represented by Anne Sheehan, Department of Finance; and John Chiang, State Controller, represented by Cindy Aronberg, Deputy Controller, were present resulting in a quorum.

Advisory members Theresa Parker, Executive Director of the California Housing Finance Agency, and Lynn Jacobs, Director of the Department of Housing and Community Development, were also present.

Approval of the Minutes of the February 21, 2007 Meeting (Agenda Item 2) (Action Item)

Anne Sheehan moved approval of the minutes from the February 21, 2007 meeting with the following amendment to Agenda Item 7 on Page 4. The Controller's Office abstained based on the fact that the background materials were not received in sufficient time to complete the legal review. Cindy Aronberg seconded the motion. The motion passed unanimously.

Executive Director's Report (Agenda Item 3) (Informational Item)

Joanie Jones Kelly stated the following:

- There are six Exempt Facility projects requesting allocation.

 There are four Industrial Development Bond (IDBs) projects requesting allocation.
- In the Single Family Program Pool there are two projects requesting Mortgage Credit Certificates (MCCs) authority and one project requesting Mortgage Revenue Bond (MRBs) allocation.
- In the Qualified Residential Rental Pool there are a total of twenty-seven projects requesting allocation in the rural, mixed and general pool.
- For all CDLAC Program Pools on the March agenda there are a total of forty projects for a recommendation of \$872,384,332 in tax-exempt bond allocation.

Consideration of Appeals and Applications for an Allocation of the State Ceiling on Qualified Private Activity Bonds for Exempt Facility and Awards of Allocation (Agenda Item 4) (Action Item)

a. Consideration of Appeals

There were no appeals.

b. Announcement of pool deemed competitive

The Exempt Facility Pool received a total of \$511,925,000 in requests for allocation for 2007. The Exempt Facility Pool has an available allocation total of \$440,000,000. The Exempt Facility Pool is oversubscribed for calendar year 2007. Therefore, according to CDLAC Procedures the Exempt Facility Pool must be designated competitive. Based on the CDLAC competitive guidelines staff is recommending that subsequent to the March 2007 allocation meeting, the Exempt Facility allocation be limited to \$40 million for each allocation round, (May, July & September). If usage of allocation is less than anticipated in other program areas, the Exempt Facility projects may be considered for allocation in December 2007.

c. Consideration of Applications

Program Analyst Walter Akiyama stated the following:

- The Committee received six Exempt Facility applications; five applications were submitted from CPCFA and one from California Statewide Communities Development Authority (CSCDA).
- All six projects are First Tier (small business) projects. Four projects; The Ratto Group of Companies, Green Waste Recovery, Inc., CR&R Inc., and California Waste Solutions, Inc. are First Tier Projects under regulatory mandate. CalPlant I and Enertech Environmental California are First Tier projects Not under regulatory mandate.
- Staff Recommends approval of the (6) Exempt Facility applications for a total of \$321,425,000 in tax-exempt bond allocation.

Joanie Jones Kelly stated that the following Agenda Item would be presented as a separate item to the Committee. Cindy Aronberg left the meeting.

2. Consideration of applications

Misti Armstrong stated that the Committee received two applications requesting Mortgage Credit Certificate (MCC) Authority. The fair share allocation recommendations are the City of San Diego for \$4,935,354 and the County of Alameda for \$5,664,060 for a total allocation recommendation of \$10,599,414.

The Committee received one application requesting Mortgage Revenue Bond allocation from the California Department of Veterans Affairs. Staff recommended \$140,000,000 in allocation for the CalVet program.

Staff recommended approval of the award of allocation sufficient to fund the MCC program for \$10,599,414 and the Veteran Mortgage Revenue bond program for \$140,000,000 for a combined total of \$150,599,414.

2. Consideration of Applications

Joanie Kelly stated that the following items would be presented to the Committee at this time.

Cindy Aronberg stated that while the Controller's Office does not believe that there is an actual conflict of interest on these particular items, out of an abundance of caution, she will not participate. Ms. Aronberg left the meeting.

Ms. Kelly stated that the San Pedro Apartments project (07-046) is requesting an exception to the \$30 million project cap per project imposed by Section 17.IV of the CDLAC Procedures.

Staff recommended that the Committee waive the maximum allocation amount for the San Pedro Apartments project (07-046) based on the fact that demand for rental projects is such that the maximum allocation amount is not warranted due to the lack of competition there will be excess allocation for the current round.

Anne Sheehan moved approval of staff's recommendation. Bettina Redway seconded the motion. The motion passed 2-0.

Staff recommended approval of \$78,600,000 in bond allocation to fund all three applications as requested.

Anne Sheehan moved approval of staff's recommendation. Cindy Aronberg seconded the motion. The motion passed unanimously.

The General Pool

Ms. Kelly stated that there are nineteen applications remaining in the General Pool requesting \$256,419,918 in allocation.

Two projects in the General Pool are requesting an exception to the \$30 million project cap per project imposed by Section 17.IV of the CDLAC Procedures.

• Staff recommended that the Committee waive the maximum allocation amount for the two projects, 16th & Market Apartments [\$40,000,000] (07-010) and Crescent Park Apartments [\$55,000,000] (07-012). Based on the demand for rental projects is such that the maximum allocation amount is not warranted due to lack of competition there will be excess allocation for the current round.

Cindy Aronberg moved approval to waive the maximum allocation amount for the two projects. Anne Sheehan seconded the motion. The motion passed unanimously.

Staff also recommended that the Committee award allocation sufficient to fund all demand for allocation in the General Pool for a total of \$256,419,918 with the exception of the Vida Nueva apartments project.
