Mr. Bui reported that note proceeds would be used to finance the purchase of equipment as well as the acquisition and implementation of a new cloud-based electronic medical record system.

Item # 5 Investment in Mental Health Wellness Act of 2013 County of Alameda (Fifth Funding Round), Resolution No. MH 2016-01B
