## NOTICE OF PUBLIC HEARING

Notice is hereby given that on September 24, 2014, a public hearing as required by Section 147(f) of the Internal Revenue Code (the "Code") will be held by the California Health Facilities Financing Authority (the "Authority") with respect to the proposed issuance by the Authority of its revenue bonds in one or more series in an amount not to exceed \$330,000,000 (the "Bonds").
