Request Approval for Interagency Agreement with the State Treasurer's Office (STO)

<u>Summary</u>. Staff requests the Authority's approval of the fiscal year 2011/2012 Interagency Agreement with the State Treasurer's Office (STO) to provide administrative support to the Authority in the amount of \$409,823.00.

**Background.** Through Interagency Agreements, the STO provides budgeting, personnel, accounting, information systems, and other administrative support services for the Boards, Commissions, and Authorities (BCAs) chaired by the State Treasurer. The overall cost is allocated among the BCAs based on each agency's personnel years. The Interagency Agreement between CPCFA and STO is currently up for renewal and staff is requesting board approval of the new agreement.

Costs are calculated, based in part, on a formula involving the number of staff we have and space we occupy. This fluctuates from year to year and helps account for the drop in our costs in the prior fiscal year. It is also based on the STO costs which rise as other costs rise.

The Executive Director has authority under a resolution passed by the Board to approve contracts in amounts up to \$300,000. The proposed contract exceeds this amount; therefore the Board's approval is required. This year's contract amount represents an increase of 32,351.00 from the 2010/2011 fiscal year Interagency Agreement of \$377,472.00.

## RESOLUTION OF THE CALIFORNIA POLLUTION CONTROL FINANCING AUTHORITY AUTHORIZING THE EXECUTIVE DIRECTOR OR DEPUTY EXECUTIVE DIRECTOR TO SIGN AN INTERAGENCY AGREEMENT WITH THE STATE TREASURER'S OFFICE

**WHEREAS,** the California Pollution Control Financing Authority ("Authority") was created under the provisions of Section 44500 of the Health and Safety Code; and

**WHEREAS,** Section 44522(c) of the Health and Safety Code provides that the Authority is authorized to "do all things generally necessary or convenient to carry out its powers"; and

**WHEREAS,** the California Pollution Control Financing Authority wishes to enter into an Interagency Agreement with the State Treasurer's Office, the term of which will be July 1, 2011 through June 30, 2012; and

**WHEREAS**, pursuant to the Interagency Agreement, the State Treasurer's Office will provide administrative support services, including but not limited to, accounting, budgeting, legal services, information technology services, information security office, personnel, and business services; and

**WHEREAS**, the State Treasurer's Office has the ability and expertise to advise the Authority on matters pertaining to administration and support services for the Authority.

**NOW THEREFORE BE IT RESOLVED,** that the Executive Director or Deputy Executive Director of the Authority is hereby authorized to prepare and execute an Interagency Agreement with the State Treasurer's Office in the amount not to exceed \$409,823.00.

**FURTHER**, that the Executive Director or Deputy Executive Director shall execute and submit the Interagency Agreement to the Department of General Services for approval.
