SUMMARY

ANNUAL REPORT TO THE LEGISLATURE FOR CALENDAR YEAR 2001

APPLICATIONS RECEIVED

Authority staff received 15 new applications for a total dollar amount of \$221,843,000.

INITIAL RESOLUTIONS ADOPTED

The Authority took initial action (induced) on 11 of the new applications for a total dollar amount of \$201,850,000.

FINAL RESOLUTIONS ADOPTED

The Authority took final action *to sell bonds* for 20 existing applications for a total dollar amount of \$582,750,000.

BONDS SOLD

The Authority sold 18 tax-exempt bond issues and 1 taxable bond series for a total amount of \$199,360,000. One Authority bond issue was for a refunding in the amount of \$13,995,000.

BONDS AUTHORIZED BUT NOT SOLD

Two applications (Waste Management, Inc. and Pacific Gas and Electric) were approved for sale but remained unsold totalling \$148,500,000.
