#### 1. APPLICATIONS RECEIVED

Authority staff received 13 new applications for a total dollar amount of \$207,160,000. (See <u>Table 1</u>)

#### 2A. INITIAL RESOLUTIONS ADOPTED

The Authority took initial action (induced) on 13 applications for a total dollar amount of \$206,860,000. (See <u>Table 2</u>)

#### 2B. FINAL RESOLUTIONS ADOPTED

The Authority took final action to approve the sale of bonds on 12 existing applications for a total dollar amount of \$196,720,000. (See Table 3)

#### 3. BONDS SOLD

The Authority sold 14 tax-exempt bond issues for a total of \$215,085,000 and no taxable bonds. (See Table 4)

#### 4. BONDS AUTHORIZED BUT UNSOLD

There were two Bonds authorized by the Authority that did not issue in 2006 and sold in 2007. (See <u>Table 5</u>)

#### 5. PROJECTED NEEDS AND REQUIREMENTS FOR 2007

The Authority has sufficient funds to operate its programs for the coming year and has no need for General Fund assistance.
