Treasurer Ma welcomed those on the phone line to the California School Finance Authority (CSFA or Authority) Board (Board) meeting. Executive Director Katrina Johantgen read the prompt regarding the teleconference line and public participation.

### Item #2: Resolution No. 21 – 20 – Approving the Charter School Facilities Credit Enhancement Grant Program (CDFA #84.354A) Award in an Amount Not to Exceed \$1,000,000 to Granada Hills Charter School K-12 located in Los Angeles County (Action Item)

Executive Director Katrina Johantgen presented the item and noted that Resolution 21-20 is a stand-alone item, and this award is not additive to the award made to Granada at the Authority's June meeting. This award of \$1 million replaces the \$500,000 award made previously. Ms. Johantgen introduced Joe Crowley, Director at Ziegler, and Tammy Stanton, Chief Financial Officer of Granada Hills Charter. Mr. Crowley spoke to how the additional funds would enhance the school's savings and provide tremendous efficiencies in the marketplace for the upcoming financing. Ms. Stanton spoke next, outlining Granada Hills Charter plan to update the school's campus, including adding 350 additional seats for students, and invited the board to visit the campus once the upgrades had been completed. Ms. Stanton thanked the board for the grant and expressed how the funds not being financed would go directly to the classroom.

Executive Director Johantgen emphasized the importance of utilizing the Authority's three federal enhancement grants and affirmed that staff recommended the approval of this item.

Board Member Mireles thanked the Authority staff for providing clarification on the differences between this item and the Granada Hills item from the June 24, 2021 board meeting and motioned to approve the item.
