Treasurer Lockyer Awards More Than \$146 Million in Federal and State Tax Credits for Affordable Housing Projects Across the State ARRA Funds Also Awarded, Brings Stimulus Total to More Than \$574 Million

SACRAMENTO – Treasurer Bill Lockyer announced the State today awarded \$146.9 million in tax credits to affordable housing projects across the state, creating more than 4,862 units for low-income families and individuals. The State also awarded \$49 million in federal stimulus money to affordable housing projects, bringing the total amount awarded to date to \$574.9 million.

"The projects that these funds will enable are a critical piece of California's economy," said Lockyer. "The credits will help spur new construction that will create jobs and the stimulus money will revive old projects, putting people back to work. Together they'll provide a needed source of housing for low-income families and individuals."

The California Tax Credit Allocation Committee (CTCAC), chaired by Lockyer as Treasurer, approved the tax credits – both state and federal – and stimulus money awards. Tax-credits can be used to construct or rehabilitate low-income housing. Developers use the credits to attract investment capital to help finance projects.

Stimulus money can be used in place of previously awarded tax-credits, which project developers have found difficult to sell during the market slump. Provisions in the American Recovery and Reinvestment Act (ARRA) of 2009 allow prior and current tax-credit recipients to exchange those credits for cash at 85 cents for each \$1 of tax credit. While credits generally are distributed annually over 10 years, the exchange funds will be awarded in a lump sum. Developers could have cash in hand in as few as 60 days.

Projects awarded the tax credits today will be eligible to apply for ARRA exchange funds at CTCAC's December meeting if they are unable to sell the credits or attract the necessary amount of equity from them. Applications for the exchange funds are due by November 10.

CTCAC administers federal and state Low-Income Housing Tax Credit Programs in California. Both programs were created to encourage private investment in affordable rental housing for households meeting certain income requirements. CTCAC also administers a Farmworker Housing Assistance Program and a Commercial Revitalization Deduction Program.
