#### **MINUTES**

## PMIB DESIGNATION

Ms. Tranice Rainey of the State Treasurer's Office presented a Portfolio Summary Report as of April 30, 2017. On that day, the portfolio stood at \$76.458 billion. The effective yield was 0.912%, the quarter-to-date yield was 0.884% and the year-to-date yield was 0.712%. The average life of the portfolio was 188 days. AB55 Loans approved were \$608 million, with a disbursed amount of \$293 million. The Local Agency Investment Fund had \$22.562 billion total deposits, with 2,447 total participants.

Mr. Chivaro moved to approve the Designation No. 1815. Upon a second by Ms. Ortega, the motion passed 3-0 with the following votes: Mr. Dowell: yes; Mr. Chivaro: yes; Ms. Ortega: yes.

#### DECLARATION OF SURPLUS MONEY/REDUCTION OF SURPLUS MONEY

Ms. Rainey presented changes in the Surplus Money Investment Fund for the period April 1, 2017 through April 30, 2017. Declaration of Surplus Money was in the amount of \$11.543 billion.
