POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Sean Collier of the State Treasurer's Office presented the Portfolio Summary Report as of December 31, 2021. The total portfolio amount was \$181.439 billion, the effective yield was 0.217%, and the average life was 340 days. The amount of loans approved was \$744 million with a disbursed amount of \$549 million. The total deposit amount for the Local Agency Investment Fund was \$36.293 billion with 2,396 participants.
