MINUTES

Mr. Tim Schaefer asked for public comments; there were none. Mr. Shawn Silva moved to approve the minutes for the February 16, 2022 meeting. Upon a second by Mr. Schaefer, the motion passed 3-0 with the following votes: Mr. Schaefer: yes; Mr. Silva: yes; Ms. Lisa Mierczynski: yes.

POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Sean Collier of the State Treasurer's Office presented the Portfolio Summary Report as of February 28, 2022. The total portfolio amount was \$199.067 billion, the effective yield was 0.310%, and the average life was 319 days. The amount of loans approved was \$744 million with a disbursed amount of \$564 million. The total deposit amount for the Local Agency Investment Fund was \$36.682 billion with 2,395 participants.

Mr. Collier then presented Designation No. 1873.

Mr. Schaefer asked for public comments; there were none. Mr. Silva moved to approve Designation No. 1873. Upon a second by Mr. Schaefer, the motion passed 3-0 with the following votes: Mr. Schaefer: yes; Mr. Silva: yes; Ms. Mierczynski: yes.

AUTHORIZATION FOR GENERAL FUND INTERNAL BORROWING

Mr. Collier presented the Authorization for General Fund Internal Borrowing for the period April 1, 2022 through June 30, 2022, which authorizes the General Fund to borrow from internal sources to meet its cash needs during periods of shortfall. The amount to be available from various internal funds is up to \$71.235 billion.

Mr. Schaefer asked for public comments; there were none. Mr. Silva moved to approve the Authorization for General Fund Internal Borrowing. Upon a second by Mr. Schaefer, the motion passed 3-0 with the following votes: Mr. Schaefer: yes; Mr. Silva: yes; Ms. Mierczynski: yes.

SURPLUS MONEY DECLARATION AND REDUCTION

Mr. Collier presented the changes in the Surplus Money Investment Fund for the period February 1, 2022 through February 28, 2022. The Declaration of Surplus Money was in the amount of \$12.046 billion and the Reduction of Surplus Money was in the amount of \$15.483 billion.

Mr. Schaefer asked for public comments; there were none. Mr. Schaefer moved to approve the Surplus Money Declaration and Reduction for the month of February. Upon a second by Mr. Silva, the motion passed 3-0 with the following votes: Mr. Schaefer: yes; Mr. Silva: yes; Ms. Mierczynski: yes.

SURPLUS MONEY INVESTMENT FUND REQUESTS

INFORMATION ITEM - New Corporate Bond Issuer

Mr. Collier noted that the State Treasurer's Office Investment Division recently approved a new corporate bond issuer, Alphabet Inc., as an authorized investment for the Pooled Money Investment Account.

Mr. Schaefer asked for public comments; there were none.

LOAN REQUESTS

Mr. Matt Lehtonen, with the Public Finance Division in the State Treasurer's Office, presented the loan requests. Staff recommended approval of three loan renewal requests (Agenda Items 6.a - 6.c). Mr. Lehtonen reported the loan requests were in compliance with the current Pooled Money Investment Account Loan Policy and upon approval would result in an increase to the outstanding loans balance by \$12.894 million.
