POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Rivera of the State Treasurer's Office presented the Portfolio Summary Report as of August 31, 2022. The total portfolio amount was \$229.289 billion, the effective yield was 1.382%, and the average life was 304 days. The amount of loans approved was \$841 million with a disbursed amount of \$663 million. The total deposit amount for the Local Agency Investment Fund was \$30.950 billion with 2,387 participants.

Mr. Rivera then presented Designation No. 1879.

Mr. Schaefer asked for public comments; there were none. Ms. Miller moved to approve Designation No. 1879. Upon a second by Mr. Silva, the motion passed 3-0 with the following votes: Mr. Schaefer: yes; Mr. Silva: yes; Ms. Miller: yes.

AUTHORIZATION FOR GENERAL FUND INTERNAL BORROWING

Mr. Rivera presented the Authorization for General Fund Internal Borrowing for the period October 1, 2022 through December 31, 2022, which authorizes the General Fund to borrow from internal sources to meet its cash needs during periods of shortfall. The amount to be available from various internal funds is up to \$85.605 billion.

Mr. Schaefer asked for public comments; there were none. Ms. Miller moved to approve the Authorization for General Fund Internal Borrowing. Upon a second by Mr. Silva, the motion passed 3-0 with the following votes: Mr. Schaefer: yes; Mr. Silva: yes; Ms. Miller: yes.

SURPLUS MONEY DECLARATION AND REDUCTION
