#### POOLED MONEY INVESTMENT BOARD DESIGNATION

Mr. Rivera of the State Treasurer's Office presented the Portfolio Summary Report as of December 31, 2022. The total portfolio amount was \$199.649 billion, the effective yield was 2.292%, and the average life was 287 days. The amount of loans approved was \$377 million with a disbursed amount of \$237 million. The total deposit amount for the Local Agency Investment Fund was \$27.654 billion with 2,378 participants.

Mr. Rivera then presented Designation No. 1883.
