# **Board Agenda Item Number Seven Marketing Update for the ScholarShare 529 College Savings Plan**

Mr. Doug Harrison, TFI, presented TFI's Marketing Update for the Plan, detailing marketing results through the second quarter of 2017 and marketing activities planned for the remainder of the year. The update included an overview of the account and asset results, 2017 budget, and marketing activities, such as online, print, radio, employer, and ethnic outreach advertising, customer direct marketing and communications, social media, public relations, and local marketing.

Member Geiogue inquired about the reasoning behind removing California from the ScholarShare rebrand campaign. Mr. Harrison responded that this was part of a large research effort which showed that this would increase the appeal of the Plan.

Ms. Yvette Haring provided an update on the activities of the field consultants.

## Board Agenda Item Number Eight Review of Administrative Performance for ScholarShare 529 College Savings Plan for Second Quarter 2017

Ms. Linda English, TFI, presented TFI's Administrative Performance Report for the Plan for second quarter 2017 and reported that TFI underperformed (by more than two percent) in one performance area, Call Center Answer Time – Within 35 seconds. Ms. English explained that during the course of April and May, they experienced significant spikes in call arrival times which negatively impacted their service level for the period. During those peak times, a number of calls had longer than average wait times.
