Board Agenda Item Number Four Review and Analysis of Investment Performance for ScholarShare 529 for Third Quarter 2018

Mr. Glenn Friedman, TFI, presented TFI's Investment Performance Report for the Plan for third quarter 2018 comparing each underlying fund allocated to the portfolios in the Plan to applicable benchmark.

Ms. Kay Ceserani, PCA, presented PCA's Investment Performance Status Report for the Plan for third quarter 2018 and outlined PCA's recommendation that the fund currently on "watch" status, TIAA-CREF Social Choice Equity Fund, remain on "watch" status.

Chair Brown asked for public comment. There was none.

Board Agenda Item Number Five 2019 Marketing Plan and 2018 Marketing Update for ScholarShare 529

Mr. Doug Harrison, TFI, presented TFI's 2018 Marketing Update for the Plan outlining marketing results through the third quarter of 2018, including an overview of the account and asset results, 2018 budget, and marketing activities. Mr. Harrison also presented TFI's 2019 ScholarShare 529 Marketing Plan Recommendations outlining marketing activities for the upcoming year.

Member Geiogue and Member Martin inquired about additional details on employer outreach and current customer perspectives about college savings. Mr. Harrison stated that he would follow-up and report back to the Board. Mr. Harrison and Ms. Haring also responded to questions from Member Acosta-Salazar and Member Sapp regarding Plan participation and marketing of 529 plans through financial advisors, respectively.

Board Agenda Item Number Six Review of Administrative Performance for ScholarShare 529 for Third Quarter 2018

Mr. Bernard McCrossan, TFI, presented TFI's Administrative Performance Report for the Plan for third quarter 2017 relative to pre-established performance criteria and reported that TFI underperformed (by more than two percent) in one performance area, Call Center Answer Time -Within 35 seconds. Mr. McCrossan provided an explanation to the Board regarding the cause for the underperformance and the steps that have been taken to address and resolve the underperformance. Mr. McCrossan, Ms. English, and Ms. Jean Seidel, TFI, also responded to the Board's questions regarding call center processes and trends.
